- SLA meetings have been changed to 9am on the second Saturday of the month and are located at Camp Hough Lakefront Building on the West side of the Lake.
- Boater's safety course June 3, 2023. Reduced price for the first 20 SLA members/family to register. Contact Bob Capurso at <u>rgcapurso@gmail.com</u>
- Grant was awarded. Study is expected to take 1.5-2 years to complete and will result in a comprehensive plan. This fits in with the Dredging project.
- Dredging Project: A two-pronged effort is underway. A property lease agreement is being finalized along with a comprehensive dredging plan that will be submitted to DEC for approval. The goal is to have both efforts in place by mid-year 2023 so that grant applications for the project can be submitted with an eye toward implementation in fall/winter 2024.
- Water Quality Golf Tourny will be July 22, 2023 at 9:00am
- Plant milkweed in 2023: The Monarch butterfly decline is in large measure due to shrinking milkweed habitat. SLAWQ is working on a plan for the purchase and distribution of the butterfly milkweed to lake residents. In addition, they plan to replant the areas where the Japanese Knotweed was removed.

Playground: Peggy Phillip

- All playground equipment ordered has arrived and will be installed before the season begins
- Future projects to include improving the baseball field, building GaGa pit {Burts Lumber has agreed to donate half the cost of materials}, purchasing a smaller slide for younger children. Also, deck box was donated for playground equipment {baseballs, mitts, bases, basketballs, GaGa pit balls, etc.} and will be placed under Gazebo.
