# **Grants** – Brad Huber

- SUBMITTED: Pomeroy Grant Sea Serpent historic marker APPROVED the metal marker and pole will arrive this winter and be kept hidden until the unveiling ceremony in the spring. Bob Murphy will plan the ceremony on the greenway.
- REDC CFA Grant \$300k Epworth groundwater mitigation plus French Drain WAITING. We submitted on July 26, will be notified in December.
- CFGB Arts & Culture Grant \$15k to hire a marketing/event consultant WAITING.
   We submitted on September 13, will be notified in January.
- Preservation League TAG Grant \$4k Building Condition Report for Stoody.
   Submitting on October 17. Notification possibly in January.
- DASNY/SAM grant from 2018 for the Epworth roof and building repairs \$100k –
  Landmark society and Senator Cooney are helping push for this funding. Noticed one
  of Borrello's district's DASNY applicants dropped off the online/updated applicants list
  (Dunkirk). I contacted them to see if they received funding for their senior center.
  They did not, and they've given up hope.
- UPCOMING: There are currently no upcoming historic preservation grant opportunities.
- Found a photo of our old SLI signs with Christian crosses on an old SLI Facebook.
   Colleen found a way to remove it. This helps keep our online presence consistent, supporting our grant work.

## **Long Range Planning** – Bob Cook & Tom Kraft

- No update provided for this meeting
- Six engraved bricks are ready to be submitted

### Rules – Tom Kraft

- We have not met, but we have discussed a tree planting rule by e-mail. (to be added to 3.1.11):
  - Any trees to be planted on Institute property, including the park, right of ways, the greenway and leased waterfronts, or the property around Hoag, Study, and Epworth, require permission from the grounds committee. Bushes on leased waterfront properties are to be trimmed no higher than 40" above the greenway and trees no lower than fifteen feet above the greenway. The Institute has the right to trim or remove any plantings on any Institute property including leased waterfront spaces.
- Revise the private tree permit application to include a 1:1 replacement or \$50 donation. *Motion made by Jim, Brad seconded, all in favor.*

### **Hoag** – Jim Kwiatkowski

- Met with Chuck Dusel at Hoag to get a status update on the building
- Reviewed the Hoag Condition Assessment Report. The building will need extensive repairs in the future. This report is quite extensive and lists repair items on an

Urgent/Essential/Desirable basis. Many repairs are dependent upon other repairs being accomplished first. We need a meeting with a structural engineer to determine what repairs may be needed and to prioritize all repair work. Current Gutter system was built by local folk with incorrect sizing. Building needs new rain collection system. Building is moving at the water table. Foundation stones are not connected affecting support. Jim suggests hiring a structural engineer. Proceed with getting bids. Introduce potential grant opportunities to offset. Foundation would be approximately \$45K. Total improvements could be approximately \$220K.

• Met with Fred Schuknecht regarding artisan use of Hoag. Of particular interest is the way these artists are displaying their work. Over the years, the artists have placed small nails in the first floor walls to display their work. These nails have been placed between the wooden joints to minimize damage to the walls. An option is to purchase an Art Gallery wall hanging system at a cost to the institute. There is a current rail with hangers. Jim to coordinate with Fred to options for purchase. Jim will come back in spring with options or email during off-season with approval.

### **Communication** – Colleen Christmann & Jeanne Owens

- The New Cottage Owners Meet & Greet is planned for June 2024. This is now an annual event.
- The Blue Dock sign need additional information added to them. "SLI Residents ONLY, Children must be supervised, Swim at Own Risk." Plans are to add this information to the existing blue signs using stencils.
- A calendar has been added to the SLI Website. Dates for programs, events, buildings, Blue Dock and Burt Park use will be added as they are requested. Continue to follow booking procedures through Craig Bateman. Board and Committee Members are first in line, then to Asbury, then to residents, and lastly non-residents.
- Work on a History Page to replace the current Wikipedia listing will be done over the winter.
- Glynne found a photo of the old SLI sign with the cross on a dormant SLI Facebook page. Colleen was able remove the pic. This helps keep SLI's online presence consistent while supporting the grant work.
- A Forms tab could be added to the website to include Rental, Building, Tree Removal, etc. Could work on these over the winter.

### **History & Preservation** –Brad Huber

- Although we have not met since the summer we have been working to:
  - 1) Identify grants that can be used to extend and re-inventory the SLI Historic District
  - 2) Create a video presentation which will explain the current historic district and boundaries, purpose of tax credits and how residents may access them which can be played on demand
  - 3) We continue to work on identifying and putting into place a system to digitally scan and store SLI artifacts and records
  - 4) Wood Window Workshop was a success, lessons were learned and we hope to do two sessions next summer
- There was some residual labor needed after the Wood Window Workshop. All the windows which are in the basement at Epworth were left to cure and should be ready for reinstallation at this time. There are a few windows left which are currently being glazed and painted at Stacy's workshop in East Aurora and two sash which were so badly damaged they were sent out for more substantial repairs. The end is in sight!
- Brad discussed about four windows on the west wall. There are leaks but there is hesitancy to fix these windows without gutter drainage being fixed. Brad and Stacy would like to have another workshop next July. 50% of the east side will be completed. Finish the east façade. At the end of the third workshop, sash to be addressed but does not include trim and sash. Drainage is causing more damage to these areas. Kris explained that two or three options were brought up. Direction should come from the Epworth Committee. Yearly maintenance should be considered.
- Joe and Tom are willing to go take a visual look to see what could be done to at least make them watertight over the window. Entire group in favor.
- Colleen offered the suggestion to reach out to the Perry Central School District, BOCES, Warsaw Central School District to assist.
- Brad to send email to all board members and committee chairs to suggest Building Committee to encompass all three building.

- All Board member to sign conflict of interest policy
- Board members to reach out to committee chairs to create reports to be submitted for board meetings
