Silver Lake Experience – Kathy Schaefer

This coming Thursday, Friday, and Saturday will be our 5th Silver Lake Experience. Our first was in 2015. It was a collaboration between SLI and Asbury Retreat Center. For those of you who are new, SLE is a three-day mini Chautauqua. A bit of history – SLI actually started the Chautauqua movement in the late 1800's.

The SLE team consists of a planning committee, volunteer committee, logistics committee, registration committee, publicity committee and a huge, huge group of

volunteers. Almost all of us – 99% are retired. SLE consists of speakers, workshops, field trips, and entertainment.

As we have done in the past, we have made every effort to minimize any intrusion into SLI residents' daily lives. Our workshops will be in our three historic buildings, and sometimes the paddleball court and gazebo. We will also have workshops at Asbury Retreat Center. Our evening concerts here in Epworth will end at 8:30pm and there will also be a few guided tours. We want to thank you for your patience. And I've been told you can still register and/or buy tickets for the concerts — all SLI residents receive a \$5 discount for each day. For those of you registered, we hope you have an enjoyable "experience".

Rules Enforcement – Tom Kraft

- History of rules enforcement
- Brief history of where we came from. Two institutes are charted in New York State. Rules were enforced by the church. 1950's divided into residential and camp. Even though the church representatives had half the vote, they wanted out. SLI was reinvented and rediscovered.
- What are the right rules? Three years were spent to review and update rules.
 Trustees are elected and trustees make the rules. Deed restricted community means to agree to abide by the rules of the community, similar to a municipality.
 Rules are given to each resident then efforts are made to enforce these rules.
 Fines are \$25/day to help change attitudes to remain a loving, caring, friendly community.

Grants – Kevin Colburn

• Introduction of grant committee and sharing of several grants that SLI has received and what they have been used for.

Recently we have made incredible progress in securing grant funding at the Institute. As such, I am thrilled to share the fruits of our labor are now approaching nearly half a million dollars in grant revenue. This achievement has enabled us to undertake significant projects that preserve and enhance our historic buildings. Here are the key updates:

These grants represent a massive financial boost, allowing us to carry out essential preservation and improvement projects. Although most of these grants require a 20% match, they have enabled us to leverage our investments to gain a much larger return, ensuring our community spaces are preserved and enhanced

effectively. In fact, in this most recent round, our match was met entirely by volunteer labor, instead of cash. Thank you to all those who outset those cost with sweat equity.

This work would not have been possible without the tireless efforts of the SLI Grants Committee and others, the Board is immensely thankful for their outstanding work. We thank our residents for continued support and patience as we navigate the funding process and work on these projects. We will keep you updated on any further developments.
